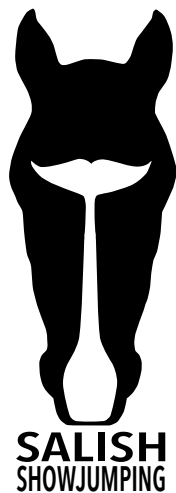

Download the EventPass (**EventPass by EquiTrace**) app and sign up directly through the app by scanning the QR code and choosing **EventPass Lite (free)**

2

Add Your Horses

On the app select **+Horse** from the main home screen. Add your horses by their **USEF number**. *Please add horse barn/pet name to their profile if included on health paperwork*

3

Upload Your Health Documents

Select **Upload** from the main home screen on the app to upload your coggins, vaccines and health certificates.

4

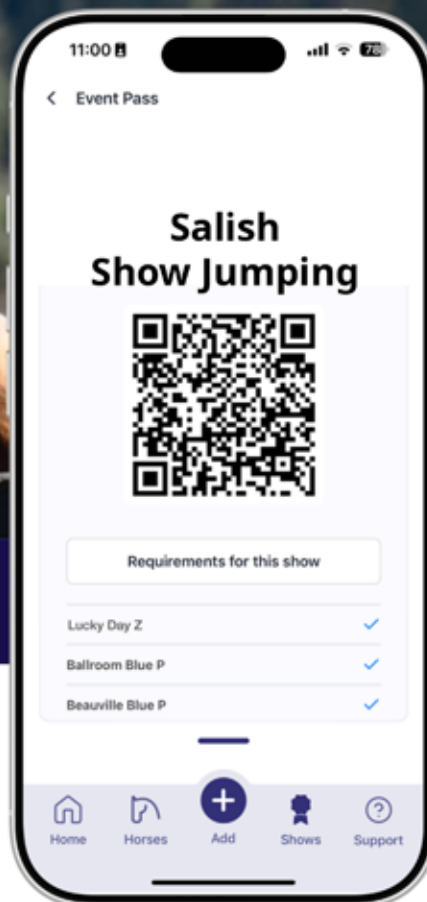
Create Your EventPass

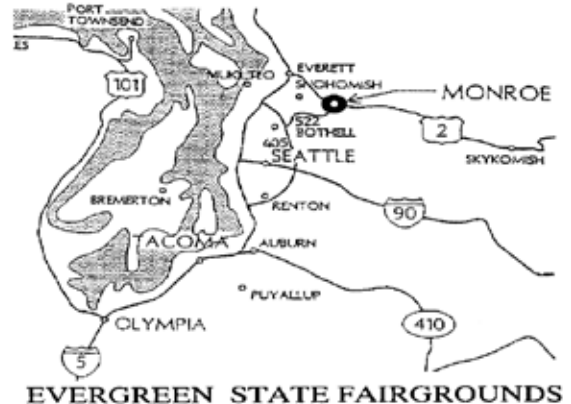
Driving Directions to Evergreen Equestrian Park at the Evergreen State Fairgrounds 14405 179th Ave SE, Monroe, WA 98272

From the North: Southbound on I-5, take exit 194 to Hwy 2. Continue East for approximately 14 miles. The Evergreen Equestrian Park is located on the left side, North of US Hwy 2, just prior to entering Monroe. Take left on 179th and watch for parking signs.

From the South Via I-5: Northbound on I-5, take Exit to Hwy 2. Continue East for approximately 14 miles. The Evergreen Equestrian Park is located on the left side, North of US Hwy 2, just prior to entering Monroe. Take left on 179th and watch for parking signs.

From the South Via I-405: Drive Northbound on I-405, take Exit 123 (Woodinville) which connects to SR 522. Travel East on SR 522 until it ends at stoplight. Take second right on 179th, and watch for parking signs.

From Hwy 2: The Evergreen Equestrian Park is 50 miles West of Stevens Pass. Follow US Hwy 2 Westbound, past the Fred Meyer shopping center in Monroe. Continue under the 522 overpass, and take right on 179th. Watch for parking signs.

RULES AND INFORMATION

ENTRY CLOSE DATE: Entries for the Salish Fall Finale close Monday, September 21, 2026.

ENTRY PROCEDURES: One check per owner. Exhibitors may submit entries with either check or credit card. Exhibitors may also enter online by credit card, at www.showgroundslive.com

1. Exhibitors may choose to pre-pay all fees, or
2. Exhibitors may pay the total of:
 - 1.) A deposit fee of \$50 per horse
 - 2.) All stall and tack room fees
3. If the entry blanks are postmarked on or before the closing date of entries and are fully complete, the \$50 deposit will be credited to the entries due. Late and/or improper entries will forfeit the deposit.

TO BE COMPLETE, ENTRY FORMS MUST INCLUDE:

- 1.) Horse's name and complete descriptions,
 - 2.) All classes or sections entered,
 - 3.) All mandatory signatures,
 - 4.) Organization membership numbers,
 - 5.) Current microchip number.
4. Trainers and owners may leave a signed open check or credit card authorization for charges during show.
All accounts are to be closed by 5:00 p.m. Sunday, or the close of the show.
 5. All entries postmarked after closing date will be charged a \$50 late fee.
 6. Exhibitors will receive their prize money within three weeks after the Horse Show.

CREDIT CARDS: Exhibitors wishing to pay by credit card will be charged a 4% convenience fee per entry.

USHJA HORSE REGISTRATIONS: All horses competing in Federation non-breed restricted licensed competitions with hunter, hunter breeding, jumper and hunter seat equitation classes (except those activities enumerated in GR901.9, items 1-11) must be properly identified and must obtain a Registration Number from USHJA. A registration number for each horse must be entered on all entry forms for licensed competitions.

CREDENTIALS: Exhibitors must present the following credentials to the horse show.

1) USEF / USHJA membership card; 2) USEF / USHJA Amateur certification; 3) USEF / USHJA Small, Junior Hunter & Pony measurement card; 4) USEF / USHJA horse recording; 5) EC membership Card

CANADIAN EXHIBITORS: Entries must be paid by draft payable in US Funds or check on Canadian US Dollar account. Canadian checks with US Funds written on the face of the check will not be accepted.

NOMINATION FEE: There will be a \$45 nomination fee for all rated jumper and equitation classes. This will allow entries to add/scratch classes until 4pm the day before.

POST ENTRIES & SCRATCHES: Post entries on the day of competition will be charged \$10 per class. Refunds will be given for scratched classes only if the show office is notified before the class starts. Scratching a Special class or Classic the Day Of the class will incur a 50% return of the entry fee.

SUBSTITUTIONS: A new horse/pony may be substituted for a scratched horse/pony. Any added or scratched classes will be treated under post entries and scratches.

TRAINER SPLITS: All splits must be done in show office by end of day Friday.

HORSE IDENTIFICATION: Horses are now required to have a back number attached to their neck or their rider when outside of their barn/tent. All horses on the property must also have current microchips registered with USEF.

CANCELLATION OF ENTRIES AND REFUNDS: Exhibitors cancelling entries after the closing date forfeit all entry fees, except in the case of disability of a horse, when entries shall be refunded upon presentation of a certificate of disability from a qualified veterinarian prior to the first class in which the horse is entered.

1. No refunds of entry fees shall be made after the first class in which the horse is entered unless a certificate of disability is presented to the horse show office.
2. No stall fees shall be refunded unless requested directly to the show secretary before March
3. Refunds will be mailed within three weeks after the Horse Show.

RETURNED CHECKS/CREDIT CARDS: There will be a penalty of \$75 per check/credit card returned by the bank for any reason. No checks/credit cards will be processed through the bank a second time. To retain entries, the fees and penalty must be paid before 4:00p.m. the day before the Horse Show starts. No personal checks will be cashed at the Show. Please plan accordingly.

HORSE SHOW OFFICE: There will be a \$75 Office Fee per horse. Show office hours are as follows:

Wednesday: 12:00 pm to 5:00 pm.

Thursday through Sunday: 7:00 a.m. to 1/2 hour after end of show.

RULES AND INFORMATION

USEF FEE: For every horse participating in any competition recognized by the USEF, a \$25 USEF fee will be collected (\$15 shall be a Drugs & Medication fee to provide for research, inspection and enforcement of rules regarding use of medications and drugs; see GR407.1, .2 and .3).

USHJA SUPPORT FEE: Every horse and pony entered in the Salish Spring Opener and Salish Fall Finale will be assessed a \$5 USHJA Support Fee.

OUTREACH SUPPORT FEE: All Outreach horses will be assessed a \$5 Support Fee.

SHOW PASS FEE: Effective 12-1-2022 any rider, handler, driver, or owner are limited to one Show Pass purchase annually (December 1-November 30). USEF Show Pass will be available for purchase by exhibitors on-line only. Competitions should not accept payment for show pass fees and therefore this fee should not appear on the entry blank. Individuals, including parents who are signing as trainer on behalf of a minor, who are participating as a trainer or coach are not eligible for a Show Pass and must obtain a Senior Competing membership to participate in a USEF-licensed competition.

PHOTOGRAPHY FEE: There will be a \$50 per horse photography fee. This fee allows each exhibitor full access and download all photos taken during the show in a low-resolution format.

MANAGEMENT: Management reserves the right to cancel or combine any classes that do not fill. Notice will be given to exhibitors affected. Management reserves the right to start the first class of any session 30 minutes earlier than the scheduled time if entries warrant. Management reserves the right to make changes of arenas, judges, or class orders to facilitate time schedule and conditions.

RIBBONS AND PRIZE MONEY: Ribbons will be awarded to six places in regular Jumper classes and eight places in Equitation classes, Classics and Mini Prix. Prize money for regular classes as follows: 30%, 20%, 16%, 13%, 11%, 10% and Classics and Special classes is as follows: 30%, 22%, 15%, 10%, 7%, 6%, 5%, 5%.

STABLING: Permanent 10' x 10' box stalls with doors and mats provided. Stalls will be available by 3:00pm beginning on Tuesday, October 6. Stalls must be vacated no later than 9:00am Monday, April 1. Fee for box is \$300 per stall fee for the week. Please indicate arrival and departure date and who you are to be stabled with on the entry blank. Exhibitors do their own stall cleaning. No stall refunds will be given unless requested to the show secretary prior to March 16. Refunds after those dates will only be made if the stall is reissued to another entry.

EXHIBITORS WISHING TO BE STABLED WITH A SPECIFIC STABLE/TRAINER MUST SPECIFY ON ENTRY FORM AND HAVE THEIR ENTRIES IN BY October 2, 2026.

SHARPS CONTAINERS: Sharps containers will be placed at the end of each barn aisle. **There will be a \$200 fine for any dumping of syringe/needles, bailing string/wire, foreign objects, garbage, etc., in stall, shavings or compost areas.**

SHAVINGS & MANURE DISPOSAL FEE: Bulk shavings will be included in the price of the stall. There will be a \$115 per shavings & manure disposal fee.

SCHOOLING AND EXERCISE: Schooling areas will be available for use before and during the show. Schooling in the performance rings will be allowed on Wednesday, October 6, 2026 from 10:00am- 5:00pm. A schooling fee of \$50 will be charged to all entries. Hard hats must be worn while schooling.

HELMETS: It is compulsory for all persons at Federation licensed hunter, jumper, or hunter/jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials), SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. It is compulsory for riders in Paso Fino classes, both open and breed restricted including Hunter Hack, where jumping is required and when jumping anywhere on the competition grounds to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials), SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. A Show Committee must bar riders without protective headgear from entering the ring for classes in which protective headgear is required and may bar entry or person from entering the ring if not suitably presented to appear before an audience. (GR801)

TRAILER OR CAMPER HOOK-UPS: Trailer and camper parking is available. Water/power hookups \$300; water/power/septic \$375.

HAUL-INS & NON-SHOWING HORSES: There will be a charge of \$50 a day per horse for horses not stabled. There will be a \$125 fee for a non-showing horse.

ARENAS & FOOTING: Indoor Jumper Ring is 120' x 248'. The footing is GGT sand. Outdoor Jumper Ring is 130' x 200' with sand footing. Covered warm up is 100' x 200' with GGT sand footing.

CONDITIONS OF COMPETITION: Every class offered herein, which is covered by the rules and specifications of the current Federation Rule Book will be conducted and judged in accordance therewith.

MEMBERSHIP STATEMENT: Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.

REMINDER: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org.

RULES AND INFORMATION

HORSES ENTERING THE GROUNDS FOR THE SALISH HORSE SHOW MUST BE ACCOMPANIED BY DOCUMENTATION OF EQUINE INFLUENZA VIRUS(EIV) AND EQUINE HERPESVIRUS(EHV) VACCINATIONS WITHIN SIX MONTHS PRIOR TO ENTERING THE SHOW GROUNDS.

MOTORIZED VEHICLES: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

EXCESSIVE LUNGEING: Lungeing a visibly exhausted horse; lunging an obviously lame horse; chasing a horse with a lunge whip or other inappropriate use of the whip; the use of a lunge whip with any type of appendage or attachment, including but not limited to bags and flags; excessive and/or disruptive cracking of the whip have all now been added to the list of prohibited acts under the Horse Welfare rules for Hunters, Jumpers, and Hunter/Jumper Seat Equitation per EQ104.1, HU100.1, and JP102.2 (#249-22).

BIO-SECURITY: GR 870 states "All riders, drivers, vaulters, handlers, owners, trainers, coaches, grooms, agents and lessors must abide by and comply with biosecurity measures and equine health requirements imposed by the Federation, Competition Management, and local, state, and federal animal health officials".

GR 873 requires fevers (unexplained temperatures above 101.50 F at rest) to be reported to the competition veterinarian and competition management no later than two hours after detection. The veterinarian will evaluate the case and determine how to proceed. The febrile horse will also be reported to the Federation, specifically to and to Dr. Katie Flynn, the Equine Health and Biosecurity Veterinarian.

Dogs are allowed within the barn areas, but must be on leash

 - ◇ Please clean up all yarn left over from braiding.
- ◇ For the safety of all, syringes and needles must be placed in sharps containers.

 - ◇ In the unfortunate event of a violation charge from the EEP, Competition Management will forward the charge to the responsible exhibitor.

Bonus points are awarded as follows: one point for obstacle number one, two points for obstacle number two, three points for number three, etc, with a total of 36 points. No point is awarded for an obstacle knocked down. This competition will take place with the first round against the clock without a jump-off. Rated & Outreach horses/riders are all eligible. Open to teams of 2 horses and riders and to be dressed in Hawaiian shirts/accessories. To be scored under USEF JP150.5. (see next page for full description). Ribbons to 8th and prize money as follows: 30%, 22%, 15%, 10%, 7%, 6%, 5%, 5%.

ROTATING PAIRS RELAY

USEF JP 150.5- Rotating Pairs Relay. This competition is for teams of two. A horse can only compete once in this class, but a rider may compete on more than one horse. The entire course *must be jumped twice* in the correct order by either competitor. The competitor who crosses the start line must jump the first obstacle and the competitor who jumps the last obstacle must cross the finish line.

a. One change is mandatory. Competitors may change over as often as they wish. A change is obligatory whenever a fault is incurred. A fault is indicated by an audible signal at which time the other competitor continues the course from the next obstacle. In the event of a disobedience, the other competitor must first jump the obstacle which has not been jumped by their partner and then continue the course.

b. Faults incurred are penalized by adding four seconds for each occurrence to the time of the round. The first two disobediences are penalized only by time, the third disobedience incurs elimination. Should a competitor jump an obstacle before their partner has landed over preceding obstacle, the pair will be eliminated.

c. The fastest overall time wins. In case of a tie for first place only, there will be a compulsory jump-off over a shortened course.

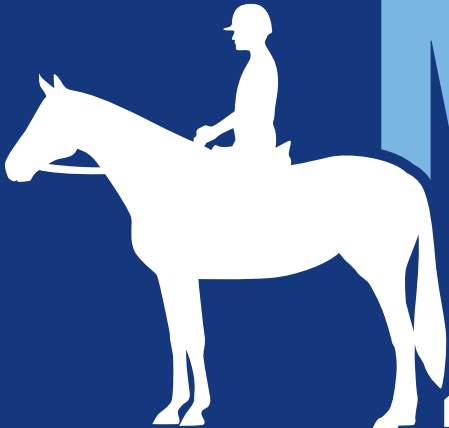
